Sl. No.	The school is directed to ensure that:
1	There is no proper signage in the lab, library, toilets and other prominent places. The school is directed to fix proper signage on all prominent places and submit the videographic compliance within 3 months.
2	The school has converted regular cubicles into CWSN toilets, but they are very narrow and there is no room for a wheelchair/walker to navigate. The grab bars are inappropriately placed these are not placed on both sides of WC. The CwSN toilets are not seen on every floor. Thus, the school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and Board's guidelines within 03 months and submit the compliance.
3	There was a rejection point that the school has not uploaded a valid building safety certificate issued by an Assistant Engineer or above rank of an appropriate government department. At the time of review, the school has not removed the deficiency. Building safety certificate shown obtained from a Pvt Engineer. Hence the school is directed to obtain the building safety certificate from appropriate government department and submit the compliance within 3 months.
	The computer lab is understocked. As per circular No.10/2023, 01 (One) Computer System per 18 (eighteen) students with minimum of 40 computer systems must be available in computer Lab. Hence the school is directed to upgrade computer lab as per SoP issued by the Board and submit the compliance within 3 months.
5	Maths lab is still understocked and looking temporary arrangement. There is not permanent demonstration table and sufficient seating facility. Hence the school is directed to upgrade lab as per SoP issued by the Board and submit the compliance within 3 months.
	The Composite lab is undersized. The workstations are not as per guidelines, these are very small. Safety measures are not being followed in Composite lab. The gas cylinder is seen inside the lab. Fire extinguisher is not installed inside the lab it is kept on shelf looking like temporary arrangement and there is no exhaust fans installed. Hence the

	school is directed to upgrade lab as per SoP issued by the Board and submit the compliance within 3 months.
7	The indoor and outdoor sports facilities are still inadequate. Hence the school is directed to upgrade sports facilities as per SoP issued by the Board and submit the compliance within 3 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
